The term "Company" and "Department" are individually referred to as such or a "Party" and collectively referred to as the "Parties".

#### WHEREAS

- A. The Company, an Industry, established in the year 2019 and engaged in the business of WRC is a global technology company specialising in services related to Data Science, Artificial Intelligence (AI), Machine Learning, Robotic Process Automation (RPA), Internet of Things (IoT), Mobile App Development, Customised software development for SME's. WRC's main vision is to automate processes with less human efforts to increase efficiency with less consumption of time by utilising the science behind the data.
- B. Department of Bachelor Of Computer Application, SBRR MAHAJANA FIRST GRADE COLLEGE (Autonomous), has entered into various collaborative arrangements with other parties to enhance the knowledge and skills of the students in the Computer Science (department) discipline.
- C. The Parties are desirous to enter into this MOU to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

### **1. AREAS OF COLLABORATION**

- 1.1 The Parties have entered into this MOU to co-operate and collaborate between themselves to promote more effective use of each of their resources and provide each of them with enhanced opportunities. Each Party shall comply with applicable laws and internal guidelines/instructions, while performing under this MOU. The Parties agree to collaborate efforts in the areas of engineering and technology.
  - Setting up a Centre of Excellence in the college campus.
  - Plan and select Innovative Project ideas.
  - Prepare and Conduct Value Added Courses with faculty and students.
  - · Seminars/Webinars/ Open Discussion with faculty and students.
  - Help students for further abroad studies in the related area of education.
- 1.2 This MOU sets out the standard terms of cooperation and collaboration between the Parties. If necessary, the Parties may enter into definitive agreements, deeds or documents as may be required from time to time to give effect to the intention of the Parties contemplated herein. Notwithstanding anything contained herein, the Parties shall mutually set out the syllabus, scope and area of work, duration, etc., before commencing any collaboration activities.

- 1.3 The relationship between the Parties is that of principal- principal relationship. This MOU does not create any principal-agent, master-servant, partnership or joint venture relationship between the Department and the Company. Each Party being a separate legal entity shall obtain all approvals, consents, permissions and licences required under applicable laws, if any, before undertaking any co-operation or collaboration activities contemplated under this MOU.
- 1.4 The Parties may set out guidelines or instructions to the students, who are beneficiaries under this MOU. The Parties agree that the concerned student/s will be personally liable for their acts or omissions committed by them within the premises of the Company or in relation to the men and materials of the Company.

### 2. DURATION AND TERMINATION

- 2.1 This MOU is for a period of 3 years with effect from January. It can be extended further by mutual consultation and agreement.
- 2.2 It is agreed between the Parties that though this MOU is arrived at to facilitate cooperation for enhancing the quality of education in the area of Industrial applications, if, during the term of this MOU, for any reason the objective is not achieved or achievable, this MOU shall be terminated by either of the Parties, by giving a 30-day written notice to the other Party and no Party under this MOU shall have any kind of claim against the other Party.
- 2.3 Notwithstanding anything contained herein, either Party may terminate this MOU with immediate effect, in case of material breach of the terms of this MOU by the other Party.
- 2.4 This MOU is on a non-exclusive basis and that both Parties are at liberty to enter into similar arrangements with any third party for similar purposes without notifying the same to the other Party.

### 3. FINANCIAL ARRANGEMENTS

- 3.1 This MOU shall not give rise to any financial obligation by one Party to another Party. Each Party shall bear its own cost and expenses in the implementation of this MOU.
- 3.2 Any payment offered to the student/s by the Company, whether stipend or otherwise, shall be directly paid by the Company to the student/s, and the Department will not be responsible for the payment/non-payment/delayed payment of any amount to the student/s.
- 3.3 If the candidate requires help which requires extra time, resources, the company shall inform the institution beforehand.

#### 4. CONFIDENTIALITY

Each Party shall undertake to observe the secrecy of confidential information received from or supplied to the other Party during the period of implementation of this MOU or other agreements made pursuant to this MOU.

For purposes of this MOU, "confidential information" means any information whether prior to or hereinafter disclosed by a Party( the Disclosing Party) to the other Party( the Receiving Party) of this MOU involving technical, business, marketing, policy, know-how, planning, project management and other information, data and/or solutions in any form, including but not limited to any information which is designated in writing to be confidential or by its nature intended to be for the knowledge of the Receiving Party or if orally given, is given in the circumstances of confidence.

#### 5. REVISION, VARIATION AND AMENDMENT

Either Party may request in writing a revision, variation or amendment of this MOU. Any such revision, variation or amendment agreed to by the Parties shall be in writing and shall form part of this MOU and shall come into force on such date as may be determined by the Parties.

### 6. INTELLECTUAL PROPERTY RIGHTS

Nothing contained in this MOU shall grant, imply or create in either Party any right, title or interest in or to the intellectual property, including but not limited to knowhow, inventions, patents, copyrights and designs, of the other Party. However, intellectual property developed by the joint efforts would be the joint property of the Parties and any financial benefits or otherwise arising out of it shall be shared proportionately by the parties in consonance with the efforts / inputs given by them.

### 7. GOVERNING LAW AND DISPUTE RESOLUTION

The terms of internship with the Company are governed by Indian laws and shall be subject to the exclusive jurisdiction of courts at Bengaluru. Any dispute or difference shall be first discussed between the Parties and resolved. If the dispute or difference is not resolved, the Parties shall refer the same to a sole arbitrator appointed by the Parties. The arbitration proceedings shall be in accordance with the Arbitration and Conciliation Act, 1996 and the seat of arbitration shall be Bengaluru.

#### (A) PREAMBLE

Whereas CSIR-IITR, a leader in toxicology research, endeavours to mitigate problems of human health and environment. The institute aims to accomplish its goals through the following objectives:

- Safety evaluation of chemicals used in industry, agriculture, and everyday life.
- To study the mode of action of toxic chemicals/ pollutants.
- Remedial/preventive measures to safeguard health and environment from pollutants.
- To study the occupational health hazards due to exposure to chemicals in industries, mines, agricultural fields and environment.
- To devise simple/rapid diagnostic tests for disorders caused by industrial and environmental chemicals.
- **4** To collect, store and disseminate information on toxic chemicals.
- To develop human resource for dealing with industrial and environmental problems.
- To provide a platform to the public and entrepreneurs to address queries and concerns regarding safety/toxicity of chemicals, additives and products.

Whereas PBMMEC is a well-known institution that caters to higher education by offering Master degree programs in Science, Arts, Commerce, Management and Ph.D. programs particularly in Biotechnology, Biochemistry, Microbiology and related branches of Life Sciences.

b) Whereas: Faculty members/Scientists of CSIR-IITR and PBMMEC agree for joint organization of conference/ workshop/ seminar/ symposia/ summer school/ training/ lectures etc. to improve the exchange of knowledge and experience, as per Institutional norms.

g) All rights, title and interest in any INTELLECTUAL PROPERTY created under the above program will be owned jointly by CSIR-IITR and PBMMEC / CSIR-IITR and PBMMEC affiliates means any individual or entity that controls, is controlled by, or is under common control (i) a controlling entity that is a state or a political subdivision or governmental authority of a sovereign state (a "Sovereign Entity"), or (ii) any entity that would be an Affiliate only due to being under common control of a Sovereign Entity.   - a) The research students at CSIR-IITR may get themselves registered for Ph.D. with the PBMMEC and CSIR-IITR Scientists can be Guide/Co-Guide for Ph.D. programme of PBMMEC, subject to fulfilment of norms and conditions of PBMMEC.
  - b) PBMMEC shall provide facilities (laboratories, library etc.) for conducting research work under the joint research projects, as per Institutional policy.
  - c) PBMMEC may offer honorary positions of Adjunct/Visiting faculty to the Scientists of CSIR-IITR, as per norms of PBMMEC.
- 3. CSIR-IITR, Lucknow will facilitate the following:
  - a) CSIR-IITR shall make available the existing facilities like laboratories, library for research/project work on the sponsorship basis to the faculties/students of PBMMEC.

#### (D) MODALITIES OF CO-OPERATION

A co-ordination committee comprising Director, CSIR-IITR, Lucknow and Principal, PBMMEC or their nominees and a programme co-ordinator of both parties who could be a faculty/scientist, or executive will be responsible for setting up and implementing the envisaged research activities. #### (F) AMENDMENT

The MoU can be amended only by written consent duly signed by signatories or their nominees. The MoU between the said CSIR-IITR, Lucknow and PBMMEC, Mysuru will come into force after getting approval of the authorities or their nominees. The parties acknowledge and agree to fulfil requirement and to undertake all activities identified under this MoU. This MoU become effective from the date when signed by both the parties and will be valid for five years which may be extended for a period suited by both the parties and will be valid for both the parties. The confidentiality maintaining period will be of three years from the date of expiry of MoU.

#### (G) ARBITRATION CLAUSE

In the event of any question/dispute/difference arising under the agreement or in connection herewith (except as to matters the decision of which is specifically provided under this agreement) the same shall be referred to the Delhi Arbitration Centre for appointment of Arbitrator to adjudicate the dispute. The award of Arbitrator will be final and binding on the parties. The Arbitrator may give interim award(s) and/or directions, as may be required. Subject to the aforesaid provision, the Arbitration and Conciliation Act, 1996 and the rules made hereunder and any modification thereof from time to time being in force shall be deemed to apply to the Arbitration proceedings under this clause.




